This is to bring to your kind knowledge that the Standing Committee of Legal Education Committee of Bar Council of India by virtue of its meeting held on 16th June, 2024 considered the matter of Shree Ramakrishna Vivekananda Mission College of Juridical Studies, Howrah, West Bengal.

After consideration, extension of approval of affiliation has been granted to Shree Ramakrishna Vivekananda Mission College of Juridical Studies, Howrah, West Bengal for imparting five year BA LL.B course with existing strength of one section alongwith one additional section i.e. total two sections of 60 students in each section and fresh approval of affiliation has also been granted to three year LL.B course and five year BBA LL.B course with intake of two sections of 60 students in each course for a period of one year i.e. for the academic year 2024-25.

Further, College is directed to appoint 10 law teachers within a period of one year who shall be paid UGC scale. The proof of the same should be furnished by way of duly notarized affidavit alongwith adequate documents including appointment letters, salary statements etc.

In case the CLE fails to comply with the aforementioned shortcomings, no admission shall be made from the next academic session 2025-26.

This is to bring to your kind knowledge that the Standing Committee of Legal Education Committee of Bar Council of India by virtue of its meeting held on 28th September 2024, has considered the letter dated 28.09.2024 received from Shree Ramakrishna Vivekananda Mission College of Juridical Studies, Howrah, West Bengal requesting to convert two sections of five year BBA LL.B integrated degree course into two sections of five year BA LL.B integrated degree course.

It is to be noted that the CLE was had already been operating 2 sections with respect to the above stated course, till now. Initially it had been granted one section and thereafter vide letter dated 04.07.2024 they had been granted one additional section for the same course in addition to the existing one section of the CLE which had been in operation earlier.

After consideration, the Committee has accepted the request made by Shree Ramakrishna Vivekananda Mission College of Juridical Studies, Howrah, West Bengal.

In view of the above, now fresh approval of affiliation has been granted to Shree Ramakrishna Vivekananda Mission College of Juridical Studies, Howrah, West Bengal for two additional sections with respect to its five year BA LL.B integrated degree course with 60 students of each section for a period one year i.e. for the academic year 2024-2025.
